

Auswanderung Wilmhoff 1867 – 1892

In dem Buch „Lohner Familien“ ist unter „Wilmhoff“ in der vierten Generation die Familie von Hermann Wilmhoff und Maria kl. Krogmann aufgeführt. Bemerkenswert ist auch hier, dass die drei jüngsten ausgewanderten Kinder von Pagenstert nicht mit aufgeführt werden. Der älteste Sohn hat die Stelle übernommen und war Eigner und Torfstreufabrikant am Moore. Eine Tochter ist 1892 ausgewandert und ist auch im Buch nicht aufgeführt.

Die beiden jüngeren Schwestern Maria Elisabeth und Josephina, haben jeweils einen Südbeck geheiratet. Diese beiden Familien sind nach Nemaha in Kansas 1884/1885 ausgewandert und haben dort eigene Farmen bewirtschaftet. Bernard Gellhaus ist kurze Zeit später ebenfalls dorthin ausgewandert.
